Shareholder agreements

When setting up a new business, the last thing most people think about is 'what if things go wrong' – luckily, that is exactly what solicitors are paid to do and plan for on their clients' behalf.

At its heart, a Shareholders' Agreement is a contract between the shareholders of a company which governs their relationship with each other and the company itself. By contrast with the company's Articles, which are a matter of public record available at Companies House and strictly governed by legislation. The Shareholders' Agreement is a private, confidential document with a lot more flexibility in what it may contain, and it may even contain provisions that would not be included in the Articles – such as commercially sensitive rules or provisions. Often, this agreement will set out the shareholders' personal rights and obligations, any limitations on their rights as granted by the Articles, their expectations, and certain protections for different categories of shareholders.

For example, a start-up may need to reinvest any profit it makes for the first few years back into the business, so the shareholders may agree to waive any right to dividends for a set period. The shareholders may wish to have the power to name or remove directors in certain set circumstances, such as deadlock or conflicts of interest, where otherwise they could be forced to follow the much more complex process of removal granted by legislation. Some shareholders, as often seen in family businesses, may wish to ensure that shares cannot be transferred outside of the existing company structure or in-group, or may wish to ensure their family is able to inherit their shares as part of their legacy.

Where the shareholders wish to have more control over the day to day running of the company's business, it is possible to set out a clear list of things which the directors may otherwise be able to do, but which the Shareholders' Agreement would require a pre-determined level of consent from the shareholders - or a specified category of them. Often this is used where one shareholder may wish to invest capital but allow the others to run the company – they can still set requirements for what things can be done with the company, or how the company can be run but allow the directors with more expertise to deal with the day-to-day aspects of the business.

Another key function of a Shareholders' Agreement is letting the parties consider in advance what they would do if the worst happened – death, business failure, dispute, all could deteriorate any initial good faith between the parties to the point where an exit strategy is needed. An aggrieved shareholder is not left with many options in the case of deadlock or dispute if the other shareholders are not willing to work together to find a solution or buy them out. They may even be left holding shares in a hostile company with no ability to sell their shares to a third party or participate in the business effectively. A difficult shareholder may refuse to sell their shares and prevent a company buyout if not otherwise required to cooperate under a Shareholders' Agreement.

A good solicitor will be able to guide shareholders through future proofing their company, whether at the onset or at any point during its lifetime. They will be able to identify possible weaknesses in the structure of the company and help make contingency plans. A good Shareholders' Agreement will set out expectations for how the parties should behave both during and after its lifetime, a process to follow should the worst happen and remedies for the parties to know what to expect.

As with most contracts, the most common remedy for breach of the Shareholders' Agreement is damages, but other relief may be available – such as an injunction preventing the other parties from doing something damaging to the claimant, or an order compelling the other parties to act in a certain way. One of the biggest advantages of having a Shareholders' Agreement is that the court can clearly see the parties' intentions at the onset and, oftentimes, will be able to follow what the parties themselves agreed should be done.

The cost of putting in place a Shareholders' Agreement may seem like an unnecessary expense for some, until they are faced with the cost of a dispute which could have been avoided by investing early in their peace of mind.

Settlement Agreements/

The benefit of using one solicitor to act for employees

When a business needs to make redundancies, it may want to consider offering enhanced terms to those employees via a Settlement Agreement. A Settlement Agreement is legally binding between the employer and the employee, and it is entered into shortly before or after the termination of the employee's contract of employment. The benefit of using this type of agreement is that it provides a clean break with the employee agreeing to waive their rights to make a claim, instead receiving an agreed amount of compensation.

Employees should obtain independent legal advice before entering into a Settlement Agreement which the employer usually contributes a fixed sum towards the cost of, but it can be a more cost effective and faster process for all parties to have one independent legal advisor to do this work.

Where one firm is appointed to sign off multiple Settlement Agreements it will be a faster and more efficient service, but employees do still have the right to choose their own solicitor if they decide to do so.

I recently acted for a group of employees who were unfortunately made redundant and

were offered a Settlement Agreement by their employer. After speaking to each employee individually and making sure they understood the terms of the agreement, they were all signed, and the process concluded swiftly. This helped to reduce costs for the employer and allowed for the fast conclusion of the matter for all parties, allowing employees to seek alternative employment opportunities and the employer to progress with their future plans for the business.

Conveyancing for plot sales

It is important to have the right legal team on your side when preparing for and managing the sale of individual residential plots either those with planning permission for self-builders or off plan new build homes. Here at Gullands, we work with developers across Kent typically with developments and plots up to 20 homes.

Many sites will have a unique and complex range of legal challenges, so issues such as compliance with planning permission, boundaries, access, wayleaves, restrictive covenants, rights of way, utility connections, private drainage, building guarantees and the establishment of management companies to transfer to and manage communal land / roadways.

We work with developers to make sure all these matters are dealt with prior to and during marketing and throughout the sale transactions so it ensures the conveyancing process runs smoothly and completion delays are kept to a minimum, allowing the developer to exit and move onto the next development as quickly as possible. For each site we create a document pack which then allows the transfer of individual properties to go smoothly, anticipating and answering all the buyer's solicitor's questions.

We have recently acted for developers with plots ranging from a site acquired to demolish the existing building and replace it with a pair of semi-detached residential properties, a small development of five new luxury homes and a larger development of 10 new homes.
